**RESIDENT/PROPERTY OWNER:** A PERSON AND THEIR IMMEDIATE FAMILY WHO RESIDES OR OWNS PROPERTY IN THE CITY AT THE TIME THE SERVICE IS REQUESTED.

**NON-RESIDENT/NON-PROPERTY OWNER:** A PERSON AND IMMEDIATE FAMILY WHO DOES NOT RESIDE OR DO NOT OWN PROPERTY IN THE CITY AT THE TIME THE SERVICE IS REQUESTED.

**IMMEDIATE FAMILY:** AN IMMEDIATE FAMILY CONSISTS OF THE ADULT PLUS THEIR SPOUSE, CHILDREN AND PARENTS THAT RESIDE WITH THE ADULT. IT ALSO INCLUDES CHILDREN THAT ARE NOT RESIDING AT THE ADULT'S RESIDENCE FULL TIME BECAUSE OF ATTENDANCE AT A SCHOOL.
