COMMITTEE & BOARD REPORTS

- Lori Tubbergen Clark, Newaygo County Commissioner, provided handouts and discussed Newaygo County Commission on Aging statistics and Newaygo County Medical Examiner's Office statistics. She also discussed and distributed a copy of the 2024 Newaygo County Central Dispatch Annual Report.
- Ramona Deters, representing River Country Chamber of Commerce, spoke about Chamber events that are occurring in the coming months and said that the annual meeting will be held on May 1^{st} at the museum. Deters stated that the Newaygo Farmers Market will start on June 6^{th} .

Newaygo District Fire Chief Otteren gave an update on call numbers.

CITY MANAGER REPORT

Schneider stated that a City Manager written report was included in packets. Council Members had no questions.

DEPARTMENT REPORTS

- Ron Wight, DPW Superintendent, discussed the Wood St water/sewer main project and the water service line project and said they will both begin in the next few weeks.
- Chief Andres said that the School Assigned Police Officer agreement expires this spring and a new agreement would be coming to Council next month. She said that she is reviewing policies for any potential updates that may be needed in the Police Department.

BOARD BUSINESS

- Motion by Walerczyk, second by Black to approve Resolution 2025-05 approving Liquor Licenses for 18 W State Road. AIF/MC
- Motion by Black, second by Engemann to approve Resolution 2025-06 adding 18 W State Road to the Social District. AIF/MC
- Motion by Black, second by Engemann to approve Special Land Use Request by Donna Friar to change her building at 47 N State Rd to a fully residential use in a commercial district. AIF/MC Schneider stated that the Planning Commission had reviewed the request last week and recommended approval of the request.
- Motion by Engemann, second by Walerczyk to approve Ordinance 2025-02 to amend various chapters of the City of Newaygo Zoning Ordinance regarding Short-term Rentals. AIF/MC Schneider stated that the "Draft" Ordinances and Resolution related to short-term rentals had been brought to previous Planning Commission and Council meetings. He stated that the Planning Commission had recommended adoption of Zoning Ordinance changes.
- Motion by Walerczyk, second by Engemann to approve Ordinance 2025-03 to permit and regulate Short-term residential rentals within the City to ensure the public health, safety, and welfare, and to provide penalties for violations thereof. AIF/MC He stated that the Planning Commission had recommended adoption of Zoning Ordinance changes.
- Motion by Black, second by Engemann to approve Resolution 2025-07 setting the fees for various activities and requirements relating to Short-term rentals. AIF/MC
- Motion by DeVries, second by Black to approve engineering proposal, from Fishbeck, for Pocket Park design and construction phase in the amount of \$47,250.00. Roll Call: <u>Yeas:</u> Black, DeVries, Engemann, Fedell, Walerczyk Nays: None Absent: Burns MOTION CARRIED
- Schneider displayed potential concepts of the future look of an open air pavilion for the Powerhouse Building, which the architects had designed. He said that no decision was needed at this time, but was looking for Council input. Council Members had concerns with potential skateboard users at the building and potential vandalism and graffiti. Schneider and Council discussed the potential need for lighting and cameras at the Powerhouse Building.
- Motion by Black, second by Walerczyk to approve Resolution 2025-08 adopting the Newaygo Fire District Budget for FY 25/26. Roll Call: <u>Yeas:</u> Black, DeVries, Engemann, Fedell, Walerczyk <u>Nays:</u> None <u>Absent:</u> Burns MOTION CARRIED The Newaygo Fire District Budget for FY 25/26 was included in packets.
- Schneider went over the budget in detail; discussed some highlights and explained some revenue and expenditures.
- Schneider and Council Members discussed Charter Revision and recommended that information be included in the City's fall update letter sent to residents.
