She stated that the County jail bond and the Newaygo Medical Care Facility bond had recently been paid off.

CITY MANAGER REPORT

Schneider discussed information included in packets that discussed Materials Management Plan which is required, by the State, stating that Newaygo County partners with other counties in the state through West Michigan Shoreline Regional Development Commission to complete the plan.

DEPARTMENT REPORTS

Ron Wight, DPW Superintendent, stated that paving was recently completed in the South Parking lot and Riverfront Park Phase 2 and striping would occur this week in both areas.

Schneider said that a copy of the detailed budget was included in packets stating that line amounts were bolded which needed to be amended. Schneider answered Council Member questions related to a few specific line amounts.
