CALL TO ORDER

Schneider stated that the NCRA Audit for FY 2022-2023 was included in packets and there were not any issues.

Schneider said that the ADA Parking Spaces and additional concrete in front of the parking spaces at the Pickleball Courts was complete. Schneider gave an update on the Skate Park repairs being done by the Newaygo High School Engineering Science Class and said the repairs were going well. duChemin stated that the concrete had been poured for the dugouts at the South Centerline Field.

Schneider stated that he would be working on the 2024-2025 budget in the coming months and asked the Board for any thoughts regarding new NCRA Budget items. He said that the budget will include additional replacement of valves at the Soccer Fields and he discussed funds for Grave Lodge that had been in the budget for pest control and refinishing the floors. Schneider discussed Disc Golf Course remaining budget and said that budget will be utilized in the future for trailway work, signage and possibly concrete pads for tees.

Board Members discussed old Vera Wilsie School playground and Schneider stated that this is owned by Newaygo Public Schools. Shaw Park Pavilion was discussed stating that it may need a new roof and some repairs.

Schneider gave an update on the Powerhouse Building stating that the roof was complete and the next step would be to get some of the safety concerns completed.
