## **NEW BUSINESS**

- Motion by Westcott, second by Looman to approve AutoZone Site Plans. AIF/MC Wes Berlin, Engineer for AutoZone, was present and discussed site plan and layout for AutoZone. He stated that AutoZone is excited to come to Newaygo and would like to get started this spring. Board asked questions related to locations and time line which Berlin answered. Chambers had spoken with Schneider and stated that Schneider said he had no concerns with site plans and everything had been well vetted and AutoZone meets all Zoning Ordinances.
- Motion by Williams, second by Looman to recommend that City Manager Jon Schneider and Chief of Police Andres proceed with making necessary Ordinance Amendments related to bicycles utilizing sidewalks. AIF/MC Looman discussed map of snowmobile path and potential bike path that was included in packets. She stated that she had been discussing options with Chief Andres and Chief said that the Michigan law had been updated and that sidewalks can be shared with bicycles. Looman discussed current bike path, budget to establish bike paths/routes, and accessibility challenges of area on Adams/State St.
- S. Faulkner discussed information in packets explaining various NEDO project updates. He discussed the restoration of four downtown Newaygo properties that are in process, gave an update on the status of the pedestrian suspension bridge project and grant opportunity with MEDC, and gave an update on Christian Healthcare Centers. S. Faulkner stated that Sandmold is looking to sell their building and that he and Schneider are working with Sandmold to relocate their employees to The Stream. He said the next IAmNewaygo Public Engagement will be held on February 20<sup>th</sup> at 6:00 pm at The Stream and will focus on the pedestrian bridge and marketing and branding strategy.
